**LIST OF AUTHORIZED USERS**

This document provides a list of persons (“Authorized Users”) who are authorized to proceed to trading operations and to provide other kinds of instructions on behalf of the Account Holder. Authorized Users shall be physical persons who are duly and validly authorized to represent the Account Holder and to engage the Account Holder towards Dukascopy Europe IBS AS (hereinafter “Dukascopy Europe”) by virtue of a contractual relationship such as an employment contract. The Account Holder confirms that the Authorized Users are authorized to have direct access to Dukascopy Europe’s trading platform and to act on behalf of the Account Holder. Dukascopy Europe is fully authorized to act upon the instructions (written, verbal or electronic) of the Authorized Users. The Account Holder has to communicate immediately to Dukascopy Europe any changes to List of Authorized Users. The present List of Authorized Users shall remain binding upon the Authorized User and Dukascopy Europe until a written notice of a change has been received by Dukascopy Europe, notwithstanding any entries in any Commercial Register or any other publication, whether official or not.

Without so being obliged, Dukascopy Europe may discretionally request from any Authorized User to give indications which will allow Dukascopy Europe to establish his identity such as the name, login, pin code, etc. Except cases of gross negligence or willful default on the part of Dukascopy Europe, the Account Holder hereby undertakes to refrain from any action, legal or otherwise whatsoever, against Dukascopy Europe in case of abuse or falsification by (a) non-authorized third party(ies) of the Account Holder’s and / or Authorized User’s name, signature or other designation whether in writing or verbally.

The Account Holder understands and agrees that he is fully responsible for any instructions and orders made by the Authorized Users listed hereinafter. Dukascopy Europe, its employees, agents and affiliates, shall have no liability or responsibility, either to the Account Holder or to any third party, in connection with any instructions or orders given by the Authorized Users. Dukascopy Europe reserves a discretionary right to record telephone calls.
